As the registered owner of the vehicle, you are deemed responsible for the violation and the payment of \$158.00 penalty unless, by the due date, the owner can establish that, pursuant to F.S.316.0083 Florida Statutes, the motor vehicle:
  - a. Was, at the time of the violation, in the care, custody, or control of another person. Acceptance of this assertion by City of Orlando will result in the re-issuance of the notice to the person named in the amount of \$158.00;
  - b. Was stolen at the time of the infraction (must attach the police report);
  - c. Violated the steady red traffic control signal to yield right-of-way to an emergency vehicle or as part of a funeral procession (please attach supporting documentation);
  - d. Violated the steady red traffic control signal at the direction of a law enforcement officer (please attach supporting documentation);
  - e. Was issued a Uniform Traffic Citation (UTC) by a law enforcement officer to the driver of the vehicle for the same infraction;
  - f. The motor vehicle's owner was deceased on or before the date that the uniform traffic citation was issued.

The affidavit <u>must</u> contain detailed information supporting an exemption, and be sworn before a notary public or another person authorized to administer oaths. If your affidavit complies with the requirements of F.S. 316.0083, no further action will be taken against you and will receive a notice of dismissal.

<u>The submission of a false affidavit is a misdemeanor of the second degree, punishable under s.</u> <u>775.082 or s. 775.083, Florida Statutes, by a term of imprisonment not to exceed sixty (60) days</u> <u>and/or fine not to exceed \$500.00.</u>

 <u>CONTESTING THE VIOLATION</u>: Please complete the Local Administrative Hearing Request form and mail to City of Orlando, c/o Orlando Stops, P.O. Box 4990, Orlando, FL 32802. The recorded images and video of your violation will be submitted as evidence for the disposition of this violation. You may view the images and video online at <u>www.ViolationInfo.com</u>.

No points are assessed against your driver's license in the State of Florida for a red light camera violation. Also, payment of this violation will result in <u>no</u> record entry linked to your driver's license. However, the issuance of a Uniform Traffic Citation may result in a record entry linked to your driver's license. After the due date has expired, a Uniform Traffic Citation will be issued as per F.S. 316.0083 in the amount of \$262.00.
